6-5-1 PURPOSE. The purpose of this ordinance is to redistrict the election districts in Sac County, Iowa.

6-5-2 FACTS FOUND. The Board of Supervisors of Sac County, Iowa, hereby makes the following findings:

1. The federal government has completed its decennial census of the population of Sac County and it appears that redistricting the election districts is necessary to reflect changes in the population of Sac County as required by Section 49.3 of the Iowa Code (2001).
2. Sac County follows supervisor district representation plan "three" as defined in Section 322.210 of the Iowa Code (2001).
3. A temporary county redistricting commission has been appointed and they have established a proposal for two revised supervisor districts in Sac County. Pursuant to Section 49.4(2) of the Iowa Code (2001), the boundaries of supervisor districts shall follow the boundaries of election precincts; therefore it is necessary to change the boundaries of two election precincts in Sac County.
4. The proposed plan of the temporary county redistricting commission has been subjected to a public hearing and has been presented to the Sac County Board of Supervisors for their review. On July 15, 2003, the Sac County Board of Supervisors approved the proposed plan.
5. Notice of the revised precinct boundaries, including the date on which the Board of Supervisors will first consider the precinct ordinance, has been published at least once as provided in Section 331.305 of the Iowa Code (2001), not more than twenty (20) days nor less than four (4) days prior to the date set for the public hearing.

6-5-3 REVISED ELECTION PRECINCTS. Revised election precincts have been proposed and should be established as follows:

1. **Precinct 1** shall be comprised of the City of Schaller, Iowa; Eureka Township; Cook Township, and Sections 6, 7, 18, 19, 30, 31, and 32 of Eden Township (that part of Eden Township west of Fox Avenue from 160th to 200th Street and West of Gard Avenue from 200th to 200th Streets).

2. **Precinct 2** shall be comprised of the City of Nemaha, Iowa; Douglas Township; Delaware Township; and Eden Township except Sections 6, 7, 18, 19, 30, 31, and 32 of Eden Township (that part of Eden Township west of Fox Avenue from 160th to 200th Street and West of Gard Avenue from 200th to 200th Streets).

3. **Precinct 3** shall be comprised of the City of Early, Iowa, and Boyer Valley Township.

4. **Precinct 4** shall be comprised of the City of Sac City and Jackson Township.

5. **Precinct 5** shall be comprised of the City of Lytton, Iowa; and Cedar Township.

6. **Precinct 6** shall be comprised of the City of Odebolt, Iowa; Richland Township; Wheeler Township; and Clinton Township except Sections 32, 33, 34, 35, and 36 (That part of Clinton Township south of 330th Street and east of Ira Avenue).

7. **Precinct 7** shall be comprised of the City of Lake View, Iowa; Viola Township; and Wall Lake Township.

8. **Precinct 8** shall be comprised of the City of Auburn, Iowa; Sac Township; and Coon Valley Township.

9. **Precinct 9** shall be comprised of the City of Wall Lake, Iowa; Levy Township; and Sections 32, 33, 34, 35, and 36 (That part of Clinton Township south of 330th Street and east of Ira Avenue).

6-5-4 REVISED SUPERVISOR DISTRICTS. Revised supervisor districts have been proposed and should be established as follows:

1. **District 1** shall be composed of the cities of Schaller, Early, and Odebolt; the Townships of Eureka, Cook, Boyer Valley, Richland, Wheeler, Sections 6, 7, 18, 19, 30, 31, and 32 of Eden Township (That part of Eden Township west of Fox Avenue from 160th to 200th Street and West of Gard Avenue from 200th to 200th Streets) and Clinton Township except Sections 32, 33, 34, 35, and 36 (That part of Clinton Township south of 330th Street and east of Ira Avenue). Total Population, 3,843.

2. **District 2** shall be composed of the Cities of Nemaha, Sac City, and Lytton; the Townships of Delaware, Douglas, Jackson, Cedar, and Eden Township except Sections 6, 7, 18, 19, 30, 31, and 32 of Eden Township (that part of Eden Township west of Fox Avenue from 160th to 200th Street and West of Gard Avenue from 200th to 200th Streets). Total Population, 3,845, deviation of 2.

3. **District 3** shall be composed of the Cities of Lake View, Wall Lake, and Auburn; the Townships of Wall Lake, Levy, Viola, Sac, Coon Valley, and Sections 32, 33, 34, 35, and 36 (That part of Clinton Township south of 330th Street and east of Ira Avenue). Total Population, 3,841, deviation of two.

6-5-5 SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not effect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

6-5-6 EFFECTIVE DATE. This ordinance shall be in effect July 8, 2003 after its final passage, approval, and publication as provided by law.
