

RESOLUTION DISSOLVING THE SAC COUNTY COMPENSATION BOARD

Sac County Board of Supervisors Resolution No. 25-1028

A resolution by Sac County to dissolve the county compensation board as authorized by Iowa Code Section 331.905.

WHEREAS, the Sac County Board of Supervisors previously established a County Compensation Board pursuant to Resolution 24-0723, which was passed on the 23rd day of July, 2024, but was made to be applied retroactively to July 1, 2024, and Iowa Code § 331.905, as amended in 2024 by Senate File 2442; and

WHEREAS, pursuant to Iowa Code § 331.905(7), the Board of Supervisors may dissolve the county compensation board upon a majority vote of its members; and

WHEREAS, upon dissolution of the county compensation board, the duties and responsibilities of the compensation board contained in Iowa Code § 331.905 are transferred to the Board of Supervisors, including the requirement to set the sheriff's salary so that it is comparable to salaries paid to professional law enforcement administrators and command officers of the state patrol, the division of criminal investigation of the department of public safety, and city police chiefs employed by cities of similar population to the population of the county; and

WHEREAS, the Board of Supervisors has determined that it is in the best interest of the county to dissolve the County Compensation Board and assume its duties and responsibilities; and

WHEREAS, the legislation does not prescribe a timeline or deadline for the dissolution of a compensation board, and the Board of Supervisors may take this action at any time; and

WHEREAS, a resolution is not required for this action, but the Board of Supervisors elects to adopt this resolution to memorialize the action for posterity formally; and

WHEREAS, at its regular meeting on October 28, 2025, the Board of Supervisors voted to dissolve the County Compensation Board, with all procedural requirements for such action having been satisfied;

NOW, THEREFORE, BE IT RESOLVED by the Sac County Board of Supervisors as follows:

1. The Sac County Compensation Board is hereby dissolved.
2. The duties and responsibilities of the county compensation board are transferred to the Board of Supervisors as provided in Iowa Code § 331.905(7).

Supervisor Wissler moved to adopt the foregoing resolution.

Supervisor Fischer seconded the motion to adopt the resolution.




