**East Sac Community School District
Public Measure SS**

Shall the following public measure be adopted?

Shall the Board of Directors of the East Sac County Community School District, in the Counties of Sac, Crawford, and Carroll, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition or libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of five (5) years to levy annually a voter-approved physical plant and equipment property tax not to exceed an additional Thirty-Four Cents (\$0.34) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2027, or each year thereafter, it being understood that if this public measure should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to levy and impose a special tax for any one or more of the foregoing purposes?

Public Measure VT**

Shall the Board of Directors of the Iowa Central Community College in the Counties of Boone, Buena Vista, Calhoun, Carroll, Cherokee, Clay, Crawford, Franklin, Greene, Hamilton, Hancock, Humboldt, Ida, Kossuth, Palo Alto, Pocahontas, Sac, Webster and Wright, State of Iowa, be authorized to contract indebtedness and issue General Obligation bonds to provide funds to remodel, improve, repair, construct, erect, furnish, and equip buildings and additions to buildings for educational and workforce training, to make improvements to sites and acquire land, to contract indebtedness therefore, and issue its school bonds in an amount not exceeding \$35,000,000 for those purposes?
